During his doctoral studies, he conducted research as an erasmus student and guest scientist at the Faculty of Law of the University of Cologne and the Institute of Private International Law and Foreigners Law of the University of Cologne between 2007 and 2009, and then between July and September 2014 and 2015. He has been working as a faculty member at Istanbul University, Faculty of Business Administration, Department of Commercial Law since 2013. His master's thesis, Unjust Enrichment in Bills of Exchange (2004), and his doctoral thesis, Current Account Agreement (2012), were published as books. Negotiable Instrument Law and Transportation Law (co-author) textbooks are open access on the YÖK courses platform. He has many articles and papers published, especially in the fields of commercial law, contract law and arbitration. He has been registered in the mediation registry and has been mediating in case condition and voluntary mediation files since 2020.
