Biography

[Volkan Hacıoglu](#) was born in İstanbul, Turkey on 26 September 1977. He is the son of the poet [Muammer Hacıoğlu](#). Between 1995-1996, he studied at [Oxford House College](#) in London, affiliated with the [Holmes Institute](#), a leading international private educational institution in the world. He received degrees of Bachelor of Arts (B.A.) in 2000, and then Master of Arts (M.A.) with his thesis subject "[Welfare-Reducing Effect of Destabilizing Speculation: A Negative Informational Externality Case](#)," under the supervision of [Prof. Dr. Necati Mumcu](#) in 2003 at Istanbul University, Faculty of Economics, Department of Economics in English. In 2006 he matriculated in the Philosophy of Doctorate (Ph.D.) program in Economics with the coordination of [Prof. Dr. Adrian Masters](#) and advisor [Prof. Dr. Thad W. Mirer](#) in the Academic Staff of Research Assistant with Full Scholarship Status at State University of New York at Albany, College of Arts and Sciences. He received his Ph.D. with his thesis subject "[Money Illusion as a Cause of Nominal Inertia](#)" in 2010 and appointed to the Assistant Professorship in 2016 and then to the Associate Professorship in 2022. In his first published article, which derives from the doctoral thesis in 2010, "[Test of Money Illusion](#)," he employed [Turkey's Statistics Institute](#) (TUIK) data compiled from the Life Satisfaction Survey between 2003 to 2009 years to use a new kind of utility measurement method with the aid of Likert Scale by turning cardinal utility into ordinal, calculating on micro foundations of macroeconomics with [Lucas'](#) (1976) words "deep parameters," and thereby implemented the money illusion test for the first time in Turkey. In line with an interdisciplinary approach, he translated [The Virtual Self](#), a book by American sociologist [Ben Agger](#), subtitled 'A Contemporary Sociology' into Turkish. The work, which was published in the Cultural Studies Series of Babylon Publications in 2011 and examined the sociology of the virtual world in a literary as well as scientific style, received many references in English and Turkish in the academic literature. With the same approach, he translated American sociologist [Daniel Bell's](#) book [The End of Ideology](#), which was considered as a classic even in its first edition in 1960, consisting of articles reflecting the socioeconomic and political analysis on the exhaustion of political ideas in the fifties together with the author's new article titled "The Beginning of History in the New Century," based on the edition of [Harvard University Press](#). The translated work was published by Synthesis Publications in 2013 under the name of [İdeolojinin Sonu](#). [The End of Ideology](#) is named by the [Times Literary Supplement](#) as One of the 100 Most Influential Books since the End of World War II. Considered as an important contribution to the Turkish literature, [Daniel Bell's](#) book [İdeolojinin Sonu](#) is a basic reference work cited by many academic and scientific studies. In his research article titled "[Fisher Hypothesis and the Role of Expectations](#)," published in the [Journal of Istanbul University Faculty of Economics](#) in 2014 and whereof the first class scientific journal named [Economic Analysis and Policy](#) in the Social Sciences Citation Index (SSCI) which has been published quarterly within the body of the Australian Economics Society since 1970 by Elsevier, one of the most prestigious academic publishers in the

world and edited by Professor Clevo Wilson from Queensland University of Technology, Prof. Dr. Onur Kural in his article titled "[The Efficiency of Primary Sovereign Bond Markets in Turkey: The So-Called Fisher Puzzle Reconsidered](#)" published in the 1st issue of the 73rd volume and dated March 2022 cited, he asserted a fundamental methodological proposition with a "new" approach to the Fisher Hypothesis Test by using Fisher's original "lost" equation instead of traditional Fisher equation. In 2014, at the International Conference on Emerging Markets, Business, Economics and Finance organized by the Budapest University of Technology and Economics that is the world's oldest Institute of Technology founded in 1782 and the first institute in Europe to train engineers at university level

and the Society for the Study of Emerging Markets (SSEM) he presented his paper titled "Bayesian Expectations and Strategic Complementarity," which includes implications for macroeconomic stability. This study, which he later developed and turned into an article, was published in the [Elsevier Journal of Procedia Social and Behavioral Sciences](#) in 2015 under the name of "Bayesian Expectations and Strategic Complementarity: Implications for Macroeconomic Stability." [Prof. Dr. James R. Wible](#) from the New Hampshire University, Department of Economics in America attracted particular attention to this work, which is referred to in the international world literature, in his article published in the 1st issue of 2020 at 7th volume of [The European Journal of the History of Economic Thought](#), "[C. S. Peirce's Theory of Abductive Expectations](#)," referring both in the text and as a footnote. He authored two separate chapters with co-authors in the collective book [Innovation, Governance and Entrepreneurship: How Do They Evolve in Middle Income Countries? New Concepts, Trends and Challenges](#) published in 2017 by the publisher of founding economists such as Alfred Marshall and John Maynard Keynes and headquartered in London, one of the world's largest publishing houses, Palgrave Macmillan's branch in Cham in the Swiss canton of Zug. The chapters in this source work, edited by Prof. Dr. Sefer Şener from the Istanbul University Faculty of Economics, Department of Economics, Technology and Industrial Economics Faculty Member and the European Union Innovation Policy Management Trilateral High Level Group Secretary General Prof. Dr. Stefan Schepers, are designed within the scope of the themes determined at the World Technology, Innovation and Entrepreneurship Conference which was held every two years and attended by respected academics from the world's leading universities and he was also the Vice President of Academic Evaluation and Coordination together with the conference preparation workshop first organized at Çırağan Palace Kempinski in 2016. Daron Acemoğlu & David Liabson & John A. List's English textbook [Macroeconomics](#) which is an important reference in its field, was translated into Turkish as part of a translation project he carried out with a special working group comprised of academicians. Originally printed by Pearson Education Inc., Prentice Hall in 2015, the work was published in 2016 under the name of [Makroekonomi](#) by Beta Publishing, the prestigious brand of Turkish academic literature. He explored the role of inventions and innovations in economic change in the co-authored original article titled "[Invention and Innovation in Economic Change](#)," in the 2nd issue of the 4th volume of June-July-August 2017 of the [Journal of Economics, Finance and Accounting](#). While analyzing Transcendentalist and Mechanistic invention theories using a qualitative historicist-analytical methodology, he focused on the Cumulative Synthesis approach where economics meets the Gestalt philosophy. He examined innovative entrepreneurship under uncertainty in the original article titled "[Innovative Entrepreneurship Under Uncertainty](#)," in the 2nd issue of the 6th volume of the scientific [Journal of Business, Economics and Finance](#) dated June-July-August 2017. He adapted the Reduced Present Value approach of the famous Polish economist [Oscar Lange](#) to the Bayesian rational expectations model and focused on an alternative dynamic learning model to the Black Box Methodology of the Classical Production Function. In the collective book with the heading [Technology, Innovation and Entrepreneurship: Innovation Strategies and Industry 4.0](#) published in June 2019 again by Beta Publishing, the prestigious brand of Turkish academic literature, he authored two chapters titled "Technological Change and Entrepreneurship Augmented Production Function" and "Rational

Entrepreneurship and Strategic Innovation," in which he integrates the entrepreneurial factor into the production function. In the 2nd issue of the 61st volume dated June 2019 of the scientific journal [Comparative Economic Studies](#), where he served on the Board of Referees and published by the [Association for Comparative Economic Studies](#) (ACES), the journal editor and New York University faculty member [Prof. Dr. Paul Wachtel](#) published a letter of appreciation entitled "[Comparative Economic Studies Referees](#)" for his contribution to the evaluation of high quality articles together with 302 reputable academics from the world's leading universities. His article titled "[Innovation Ecosystems and Sustainable Development](#)" was published in the 2nd issue of December 2019 of the 14th volume of the [Journal of Entrepreneurship and Development](#) which is released twice a year, in six-month periods, under the management of Çanakkale Onsekiz Mart University Dr. İbrahim Bodur Entrepreneurship Application and Research Center. His article titled "[International Labor Organization and Information Systems Innovation](#)" in the 77th special issue of the [Journal of Social Policy Conferences](#)—which is founded in Turkey for the first time in 1948 by the German economist and sociologist, distinguished professor Gerhard Kessler and became a peer-reviewed journal since 2003—with the theme '100th anniversary of International Labor Organization' was accepted after the peer review and published in December 2019. It is the first *Journal* constituting the corpus of social politics at Istanbul University in Turkey and has an important place in the Faculty of Economics publications. He still works as a Faculty Staff at Istanbul University, Faculty of Economics, Program of Economics in English. He edited the book titled [Crashed: How a Decade of Financial Crises Changed the World](#), in which British historian [Adam Tooze](#) the Director of [The European Institute](#) at Columbia University tells the backstage of the 2008 financial crisis and has a great repercussion in the world when it is first released, for publication in VakıfBank Cultural Publications Economics Series. Since January 2020, he is the member of Editorial Board of international refereed scientific periodical "Journal of Global Business Insights," published by the University of South Florida Sarasota-Manatee which Princeton Review's educational organization ranked among America's best universities. In 2023, he is deemed worthy of VI. International Özkan Mert Honor Awards: Translation Category Honor Award given in line with the criteria of "Living Human Treasures" by UNESCO. In 2024, he received "Certificate of Excellence in Reviewing" Award given by Association of North America Higher Education International in recognition of his outstanding contribution. He lives in İstanbul ve spends certain times of the year Bruges, Belgium where his family dwells.
